### **BUSINESS ARISING FROM PREVIOUS MINUTES:**

-50-50 Update Manager Laycock met with AGLC as a representative of the CCCM group to attempt to receive additional direction with respect to the expectations around groups receiving permission to conduct 50-50 fundraisers. He will write a formal letter to request a review of qualifications leading to clarification and potential changes on behalf of some of our smaller affiliate groups.

-All associate leagues have been informed of the changes and most are developing other strategies to recover funds. Some groups will be requesting significant increases to their league fees, using this and the carbon tax as reasoning to their members.

### Finance (Andrea Czinkota)

Andrea reported a bank balance of: \$563,700. She noted that March was a strong month and the results would be available at our next meeting. We are still waiting to determine the full impact of the carbon tax on expenses and this information will be used to set targets for the 2017-18 budget in these areas. Operations and Admin salaries are expected to come in under budget by yearend.

## Club Draws (Rick Rathier)

Rick reported that the Wind-Up was well received with champions being declared in all three areas and winners to represent the Club at City Championships next week. The second year of the amended play-off structure was once again a success and a noted improvement over the mini square format with interest retained and fewer defaulted games. Men's playdowns were compressed with some teams playing on both Monday and Wednesday evenings. It was proposed that a Wednesday start to the season next year might allow for some change in this area.

It is hoped that we can return to full strength in all leagues for next season. Advertising for all leagues is occurring during the Spring League. The only commitment to SACA is the Sr. District playdowns Jan. 26-29.

### <u>Food and Beverage</u> (Bob Laycock for Reg Rowell, Chris Bean)

March has been a very strong month with many special events and banquets boosting sales to an anticipated \$15,000 for the month and a projected \$45,000 for the year.

There were some complaints during the Oilmens' event about the lack of more than 4 choices for beer which was rectified by staff. Given that we are nearing the end of the season, it is important not to have overage of draft beer on hand. Manager Laycock has made arrangements for the Inglewood club to purchase any unopened stock at the end of the season.

#### Ice/Building Maintenance (Dave York)

Dave reported that all mechanical work planned for this summer is funded and in the planning stages. He and Bob met with an interior designer to assess a plan to move forward with some upgrades to the Club. Attempts will be made to tie a colour scheme throughout the building. She presented samples and ideas for carpet, paint colors, materials to upgrade ceilings and lighting and furnishings. A budget will be developed that will allow for an initial outlay of cash with the project to be completed in stages.

<u>Bonspiels & Playdowns</u> (Sean O'Connor) The Provincial Mixed event is going well. Sean is meeting with Dan to plan the singles curling event on April 23.

## Golf / Entertainment (Chris Bean/ Rob Lane)

Manager Laycock attended the golf show with the intent to source an alternative to our Carstairs booking. It seems their prices are far more practical than anything that could be found and the date and location will be retained. (June 24.)
